### **ABOUT THE POSITION**

This position is established on the Western & Central Oregon Lands Zone, which provides boundary management, land adjustments, and rights-of-way services to seven client National Forests in Oregon. This position covers the western portion of the zone and serves the Siuslaw, Willamette, Umpqua and Rogue River-Siskiyou National Forests. The Westside boundary zone is staffed by 4 full time field crew members as well as seasonal assistants whom report to the Westside Boundary Lead. This position provides the full array of journey-level technical and professional expertise in cadastral survey; title claims, boundary disputes, and other land title management practices and procedures; and professional expertise to the Zone's land adjustment program. Remote job sites may require extended periods away from duty station. At the GS 11 level, the position requires a State land surveying license for the area of the Zone.
