ABOUT THE POSITION

This position is established on the Western & Central Oregon Lands Zone, which provides boundary management, land adjustments, and rights-of-way services to seven client National Forests in Oregon, the Siuslaw, Willamette, Umpqua, Rogue River-Siskiyou, on the westside of the Cascade Mountains and the Fremont-Winema, Deschutes, and Ochoco National Forests and the Crooked River National Grassland east of the Cascades. The Zone is staffed by 14 employees located in various locations in Oregon. This position is located in the Zone's Westside Boundary program and reports to the Westside Boundary Lead. The Westside Boundary organization serves the Siuslaw, Willamette, Umpqua, and Rogue River-Siskiyou National Forests. This position primarily works on a small crew that spends the majority of the year outdoors maintaining and marking the National Forests System Lands property boundaries as well as an array of other Land Surveying field collection projects related to engineering design & recreation. Remote job sites may require extended periods away from duty station.
